



**EMERGENCY ORDER - NOTICE OF HEARING PUBLICATIONS REGARDING
JUDICIAL NAME CHANGES**

AND NOW, this 14th day of May, 2020, this court having declared in the 32nd judicial district (Delaware County) a judicial emergency and more recently once more extended that emergent declaration pursuant to such an order of the Pennsylvania Supreme Court authorizing the same,¹ as well as Pa.R.J.A. No. 1952(B)(1)(2), and this court thus still having those authorities detailed under Pa.R.J.A. No. 1952(B)(2)(a-s), and relatedly recognizing such past emergency orders of this court, *inter alia*, postponed the civil miscellaneous lists for March 17, 2020, April 7, 2020, April 21, 2020, May 12, 2020, and May 26, 2020,² it is hereby **ORDERED** and **DECREED** in consultation with civil liaison judge that for **ALL** judicial change of name petitions previously continued by this court's past emergent orders³ the notice requirements of 54 Pa.C.S. §701(a.1)(3)(ii)(A) **SHALL** be deemed satisfied by any initial conforming publication accomplished at the time the judicial name change petition was listed for its original hearing, absent the need for additional publications upon such proceedings' subsequent listings.⁴
