### WEEKLY POLICE BLOTTER

#### **• 10/01/2023 11:30 AM, (Medical Emergency)**

Officers assisted the Riddle Memorial Hospital (RMH) ambulance paramedics in locating the subject in need of medical care and then assisted in escorting the paramedics back to their ambulance for transport of the patient.

• **10/03/2023 10:20 PM, (Building Check / Broken Windows)**

Officers assigned to Parks Patrol found a broken window in one of the buildings at the Don Guanella property. Officers found no evidence of anybody in the area at the time or inside of the building. Officers contacted the Parks Department for repair before clearing from the scene.
