### WEEKLY POLICE BLOTTER

Officers met with the reporting party who advised that their driver's license, credit and debit cards were taken from their vehicle while it was parked and unattended within the park. Officers assigned to the Courthouse Division found an individual lying on a bench outside of the facility during a routine patrol. The officers asked if the individual was ok and learned that they had been outside around Media Borough for roughly 10 hours before stopping outside of the Courthouse to rest on a bench. Arriving officers spoke with the reported victim of the assault and found them to be uncooperative and not willing to speak about the matter. **• 03/17/2023 5:45 PM, (Suspicious Persons – Circumstances)**

Officers assigned to Parks Patrol were dispatched to the Chester Creek Trails for a report of three individuals attempting to start a fire. Upon arrival officers located the three individuals and spoke with them. The three individuals told officers that they were preparing for opening day for fishing and wanted to clear a place along the creek. Officers informed the three individuals that they couldn't clear anything from the trail areas and the individuals acknowledged and understood. Officers issued a warning to the three individuals and released them.
