*The below captions are a summary of significant police responses during the listed week. The blotter does not include all calls for service attended to by the Delaware County Park Police Department.

• 04/10/2023 3:15 PM, (Medical Emergency)

Officers assigned to the Fair Acres Division received a call for a medical emergency in Building 8. Officers assigned to Parks Patrol found plywood that had been removed from a doorway at the rear of the Little Flower Manor Mansion. Officers visually inspected the internals of the building as much as they could from the outside and verbally identified themselves while attempting to make contact with anyone who may have been inside. Due to the current condition of the building, entry was not an option unless officers could confirm any other people were inside. Officers waited and listened before determining that no one was inside of the building. Officers then contacted the Parks Department to re attach the board when they could.

• 04/15/2023 10:55 PM, (Illegal Dumping)

Officers assigned to Parks Patrol found a large pile of trash and debris that had been dumped at Kent Park. Officers contacted the Parks Department to come dispose of the trash and debris when they could.

• 04/15/2023 11:01PM, (Criminal Mischief)

Officers assigned to Parks Patrol found evidence of criminal mischief and vandalism on signs in the rear of the park. Officers found the signs to be spray painted blue and black as well as part of the 476-overpass bridge that had the same-colored paint on it. The Parks Department was contacted to remove the paint when they could.
