Climate Resilience: Jaclyn Rhoads

No Update.

Currently working on updating the Energy information on the County website. They are going to update this information and bring it back to the Commission for review.

6. Zero Waste Plan Update (Ruth Abbe, Zero Waste Associates)

Ruth provided a project synopsis and recognized that all changes to the document were presented in the last meeting. At this meeting, the County would be soliciting comments on the draft which was presented in the last meeting.

A. Comments

- a. **Mike Ewall, Energy Justice Network**, requested that the language which presents the end to incineration “in the future” be removed to reflect “as soon as possible”. He also shared concerns over waste from other counties going to the Rolling Hills Landfill, filling the landfill faster than it should. Mike also requested a paragraph be added recommending Delcora move away from incineration and adopt anaerobic digestion, instead. Finally, he requested that pay as you throw has an emphasis in multi-family housing units.
- b. **BP Lyles, Delco Environmental Justice**, requested that the time frames be adjusted where low-hanging fruit is (1-3 years), medium (4 - 7), and long (8+ years), to further express the urgency.
