County Council announced the Magellan Cares Foundation Award Grants to Human Services Providers.

Chairman McBlain called on Mrs. Morrone to start today's Agenda Items.

Motion made by Mrs. Morrone approving Agenda Item 7, the Minutes of the Regular Meeting of December 12, 2018, seconded by Mr. Culp. Discussion followed. The motion carried 3-2. (Votes: 3 Yeas – McBlain, Morrone, Culp and 2 Nays - Madden, Zidek)

Motion made by Mrs. Morrone approving the request by the Controller's Office for payment of current bills, seconded by Mr. Culp and carried unanimously.

SOLICITOR: Mr. Maddren asked for Council's authorization to file eight (8) Petitions for the Termination of Parental Rights and two (2) Consents for Adoption with the Orphans Court.

Motion made by Mrs. Morrone approving to file eight (8) Petitions for the Termination of Parental Rights and two (2) Consents for Adoption with the Orphans Court, seconded by Mr. Culp and carried unanimously.

Solicitor Maddren said the County has a program whereby if a property goes through the Tax Sale process and ends up in the Repository, we offer it to the host municipality for \$1.00.

Today, we have such a property located at 2 7th Street (132' X 46'), in Upland Borough, that the County will turnover to Upland Borough Manager Michael Ciach. This property is located in an area where there is an existing parking problem. They have plans to make a parking lot at this location.

Solicitor Maddren requested a motion be made by Council to authorize this transfer.

Motion made by Mrs. Morrone to approve the request made by Solicitor Maddren to transfer the property located at 2 7th Street, Upland Borough, seconded by Mr. Culp and carried unanimously.

PUBLIC COMMENT: <u>Carl Balis, 100 E. Glenolden Avenue, Glenolden Borough</u>, commented on the Mariner 2 Pipeline.

<u>Ken Hemphill, 39 Millers Place</u>, spoke regartding non-spraying alternatives for the mosquito control and also the possibility of County Council passing a resolution asking our District Attorney to do an investigation into Sunoco as it relates to the pipeline.

<u>Eve Miari, 407 Meetinghouse Lane, Upper Providence Township</u>, spoke regarding the County making comments on the Adelphia and Mariner East pipelines at the upcoming Environmental Assessment.

<u>Jared Brennan, 111 Welcome Lane, Ridley Park Borough and Mike Gale, 51 Collier Circle,</u> <u>Ridley Park Borough (Borough Commissioners)</u>, asked for guidance and direction in securing funds for the cleanup of Ridley Lake and the silt basin.

COUNCIL: Mr. Zidek commented on the recent Martin Luther King Day activities and the recent sinkholes along the Mariner East Pipeline.

Mr. Madden echoed the concerns about the Mariner East Pipeline and his interest in exploring (along with Council) what they can do to intervene.

Mr. Culp commented about his experience in going down to the Wesley House, in Chester City, on Martin Luther King Day.

There being no further County business, nor public discussion, motion made by Mr. Culp to adjourn the meeting, seconded by Mr. Madden and carried unanimously.
