Chairman McBlain called the meeting to order followed the Pledge of Allegiance led by Grace Mulholland, a student at the Cara School of Dance. Maureen Dillon, of the Information Technology Department, gave the invocation.

On behalf of County Council, Councilman Culp presented a Resolution recognizing March as Irish Heritage Month and the Saint Patrick's Day Parade.

On behalf of County Council, Chairman McBlain presented a Resolution recognizing March as Irish Heritage Month and Resolutions to the students of the Cara School of Dance who came in today to perform some Irish dances.

On behalf of County Council, Vice Chairman Morrone presented a Resolution recognizing March as Women's History Month.

Chairman McBlain called on Vice Chairman Morrone to start today's agenda items.

Motion made by Mrs. Morrone approving Agenda Item 7, the Minutes of the Regular Meeting of February 6, 2019, seconded by Mr. Culp and carried unanimously.

Motion made by Mrs. Morrone approving Agreements, Contracts and Amendments with the Human Services Provider of Services as per the attached list. The motion is subject to the Solicitor's approval, seconded by Mr. Culp and carried unanimously.

Motion made by Mrs. Morrone approving to purchase IT Equipment for the Office of Children & Youth in the amount of \$62,295.24, on COSTARS Contract No. 003-051, as per the attached list. The motion is subject to the Solicitor's approval, seconded by Mr. Culp and carried unanimously.

Chairman McBlain called on Adam Matlawski, Solicitor for the Delaware County Authority, to give a brief description of Resolution 2019-1.

Motion made by Mrs. Morrone approving Resolution 2019-1 of the County of Delaware, PA providing the County's consent, pursuant to Section 147(f) of the Internal Revenue Code of 1986, as amended, to the issuance by the Montgomery County Higher Education and Health Authority of its bonds in an amount not to exceed \$550,000,000.00 for the purpose of financing

a project for Thomas Jefferson University in the County of Delaware, Pennsylvania. The motion is subject to the Solicitor's approval, seconded by Mr. Culp and carried unanimously.

Chairman McBlain called on Solicitor Maddren to present the First Reading of Ordinance 2019-1, which authorizes the incurrence of Non-Electoral Debt in the amount of \$22,950,000.00 by issuance of the 2019 Notes. This would be for the redemption of the 2009 Bonds, the loan capital project being covered here plus the cost of the Notes.

Solicitor Maddren said this is the First Reading of Ordinance 2019-1 and there will be a Public Hearing and Second Reading at the next Regular County Council Meeting that will be held on March 20 and followed by the consideration of adoption.

Chairman McBlain called on County Budget Director Jim Hayes and Financial Advisor Lucien Calhoun, of Calhoun Baker, to give us more details on this Ordinance. A lengthy discussion followed. At the conclusion, Council asked Solicitor Maddren to prepare a memorandum analyzing the transaction.

This grant requires a \$592,670.00 County Match. The motion is subject to the Solicitor's approval, seconded by Mr. Culp and carried unanimously.

Motion made by Mrs. Morrone approving to advertise the following Housing and Community Development Action Plan Amendment as it relates to the CDBG Program: Allocate \$34,150.00 to Darby Borough for the development of a soccer field at Pine and 8th Streets and subject to a 30-day comment period. The motion was seconded by Mr. Culp and carried unanimously.

Motion made by Mrs. Morrone approving a Grant to Aston Township for the demolition and clearance of a deteriorated structure located at 779 Hill Avenue in the amount of \$19,000.00. The motion is subject to the Solicitor's approval, seconded by Mr. Culp and carried with an abstention vote cast by Chairman McBlain, as the law firm for who he works in the private sector provides legal services to Aston Township. This addendum increases the space by 2,750 sq. ft. for a total of 11,846 sq. ft.
