Ms. Halt read a statement on school guidance. There was a lengthy discussion and explanation of CCHD's guidance recommending the closures of all schools in Delaware County until October 9, 2020 and outlining specific metrics to consider in deciding to operate virtually, hybrid or fully in person instruction. The motion failed 2-3. (Votes: 2 Yays – Zidek and Madden, 3 Nays – Taylor, Schaefer and Reuther)

Mr. Zidek stated we still need to vote on the original motion to request the Pennsylvania Department of Health and/or the PA Secretary of Health close all service of Delaware County bars and restaurants other than take out service until October 9, 2020 and that all restaurants, casinos and gyms operating in the county close until October 9, 2020 which was seconded by Mr. Madden. The motion failed 2-3. (Votes: 2 Yays – Zidek and Madden, 3 Nays – Taylor, Schaefer and Reuther)

Ms. Reuther made a motion to add a Resolution to the Agenda in recognition of August as International Overdose Awareness Month and to recognize August 31st as International Overdose Awareness Day seconded by Mr. Madden and carried unanimously. Ms. Reuther read the Resolution.

Chairman Zidek called on Mr. Lichtenstein of the Solicitor's office to read the First Reading and give a Summary of Ordinance 2020-7 expressing an intent to organize a municipal authority with the power to, among other things, receive certain interactive gaming revenues and apply such revenues to grants for projects approved by Council, and authorizing related action.

Motion made by Dr. Taylor approving Grant Agreement with the Center for Tech and Civic Life, providing for a grant to the County in the amount of \$2,172,858.00 for the purpose of planning and operationalizing a safe and secure election administration in Delaware County in 2020. Subject to the Solicitor's approval. The motion was seconded by Ms. Reuther and carried unanimously.

Motion made by Dr. Taylor to purchase one (1) Ford Police Interceptor Utility Hybrid, from Whitmoyer Auto Group, COSTARS contract #013-110 for a price not to exceed \$36,500.00. Subject to the Solicitor's approval. This motion was seconded by Ms. Schaefer and carried unanimously.

Motion made by Dr. Taylor to Advertise and issue a Request for Proposals for Economic Impact Study related to the formation of a County Health Department. The Coronavirus Pandemic has underscored the necessity to improve the delivery of public health services throughout the County, and the County Steering Committee on the formation of a County Health Department has recommended the formation of a County Health Department. An Economic Impact Study will give Council information useful in making the final decision whether to form a County Health Department as well as the size and scope thereof. Subject to the Solicitor's approval. This motion was seconded by Ms. Schaefer And carried unanimously.

Motion made by Dr. Taylor to Award legal advertising. Subject to the Solicitor's approval. The motion was seconded by Ms. Schaefer. Discussion followed. Ms. Schaefer suggested Council settle on a policy and give direction to the Executive Director to handle the legal advertising.

This grant will allow the Department of Juvenile Court and Probation Service to add one (1) new position for a total of three (3) full time liaison positions. It further provides funding for the use of temporary staff and general operating expenses in serving victims of juvenile offenders. Subject to the Solicitor's approval. This motion was seconded by Ms. Schaefer and carried unanimously.

Motion made by Dr. Taylor approving of grant funding in a maximum amount of \$3,000,000.00 to assist child care/early learning providers throughout the County pursuant to program guidelines approved by the Executive Director. Such funds to be reallocated to such grants from amounts previously allocated from the County's Coronavirus Relief Fund moneys (received under then CARES Act) to the DelcoStrong Grant Programs (Rounds 1 and 2, and nonprofit grants). Subject to the Solicitor's approval. The motion was seconded by Ms. Schaefer and carried unanimously.

Motion made by Dr. Taylor approving Agreement with Daymark Energy Advisors to provide expert advice and testimony before the Pennsylvania Public Utility Commission (PUC) related to DELCORA asset purchase by Aqua Pennsylvania. Subject to the Solicitor's approval. This motion was seconded by Ms. Reuther and carried with an abstention vote registered by Ms. Schaefer due to a conflict relationship with one of the parties.

Motion made by Dr. Taylor approving of Agreement with The Echo Group for public communication consultation in an amount of \$6,500.00 per month for twelve months beginning September 1, 2020. Subject to the Solicitor's approval. The motion was seconded by Ms. Schaefer and carried unanimously.

Motion made by Dr. Taylor approving of Central Tax Collection Department's request for refunds for the year 2020 County Real Estate Taxes for eleven (11) property owners due to overpayment of the amount of taxes due, seconded by Ms. Reuther and carried unanimously.

Motion made by Ms. Schaefer to appoint A. Richard Paul, Anne Searl and Harold Finigan to the Heritage Commission to a term ending September 2023, seconded by Ms. Reuther and carried unanimously.

Motion made by Ms. Schaefer to appoint Mary Quilter to the Heritage Commission to a term ending September 2022, seconded by Dr. Taylor and carried unanimously.

Motion made by Dr. Taylor approving Request by the Controller's Office for payment of current bills seconded by Ms. Reuther and carried unanimously.

Dr. Taylor spoke regarding Covid testing. This week's testing site is at Interboro High School. Testing will be held tomorrow from 10am to 4pm at Interboro High School. Next week, public testing will be held at the John P. McBlain Community Center in Aldan on August 25, 26, and 27. These testing sites would not be possible without the dedication and hard work of our volunteers. We truly embody what it means to be DELCO STRONG! To our new volunteers and also to those who have been volunteering for years—THANK YOU! You are the backbone of many of our grassroots community efforts.
