Motion made by Dr. Taylor to approve Minutes of the Regular Meeting of February 3, 2021 seconded by Ms. Schaefer and carried unanimously.

Rosemarie Halt and Dr. O'Mahoney gave a Covid/Vaccination Update. Discussion followed.

Motion made by Dr. Taylor approving a Resolution endorsing the Concept of the 9-11NMT and its passage through Delaware County, seconded by Ms. Schaefer and carried unanimously.

Motion made by Dr. Taylor recognizing February as Black History Month, seconded by Mr. Madden and carried unanimously.

Motion made by Dr. Taylor approving to submit Grant application to the Pennsylvania Insurance Fraud Prevention Authority for a term of 7/1/2021 through 6/30/22 in the amount of \$558,614.00. Subject to Solicitor's approval. This motion was seconded by Ms. Reuther and carried unanimously.

Peggy Wilson, 824 Drexel Avenue, Drexel Hill, PA: Ms. Wilson thanked Council for filing the petition to force the three County residents to reimburse the County for expenses incurred in defending itself against their baseless accusations of vote counting irregularities.

Rosanne Gatta, 71 Old Mill Drive, Media, PA asked a question regarding registering for the vaccine.

COUNCIL: Ms. Reuther spoke regarding Zoom events being held during Black History Month and Events in the County.

Mr. Madden also made comments regarding Black History Month specifically regarding an event the Delaware County Historical Society is hosting. You can register for their event at Padelcohistory.org. The event is going to be held on February 23rd at 6 p.m. via zoom.

Dr. Taylor also spoke regarding Black History Celebration Events and fortunately we are able to hold these events online this year due to Covid. Two such events are being held by our Library Services. There will be two book readings to celebrate Black History Month. Dr. Taylor invites students, parents and teachers to join her at these two events; one is on Friday, February 19th at 11:00 a.m. and the second will be held on Tuesday February 23rd at 7 p.m. The reading will be hosted on the Delaware County Libraries website and also on Facebook.
