Motion made by Dr. Taylor to approve Minutes of the Regular Meeting of March 3, 2021 seconded by Mr. Madden and carried unanimously.

Rosemarie Halt and Dr. O'Mahoney gave a Covid/Vaccination Update. Discussion followed.

Motion made by Dr. Taylor approving a Resolution Recognizing March as Intellectual and Developmental Disabilities Awareness Month, seconded by Ms. Reuther and carried unanimously.

Motion made by Dr. Taylor approving to Advertise Requests for Proposals to provide failover internet service to Delaware County. Subject to Solicitor's approval. This motion was seconded by Ms. Schaefer and carried unanimously.

Motion made by Dr. Taylor approving of Agreements, Contracts and Amendments with the Human Services Providers of Services as per the attached list. Subject to Solicitor's approval. This motion was seconded by Ms. Schaefer and carried unanimously.

Motion made by Dr. Taylor approving of Adoption of Delaware County's Proposed 2021 Annual Action Plan and Commencement of a 30-day public comment period. Program funding includes the Federal Community Development Block Grant, HOME Investments Partnerships, and Emergency Solutions Grant Programs. Also included is the spending plan for the County PA Act 137 Affordable Housing Fund. Project listed attached. Subject to Solicitor's approval. This motion was seconded by Ms. Reuther and carried unanimously.

Motion made by Dr. Taylor approving to Advertise the attached Housing and Community Development Action Plan Amendment as it relates to the CDBG-CV Program to mitigate the impacts of COVID-19. Motion made by Dr. Taylor approving of Compensation Study Structure recommended by McGrath Human Resources Management with a full implementation date of June 1, 2021. Subject to the Solicitor's approval. Discussion followed. This motion was seconded by Ms. Reuther and carried unanimously.

Motion made by Dr. Taylor approving of Professional Services Agreement between the County of Delaware and TRION for Benefits Brokerage Consultancy with an effective Broker of Record date to be negotiated immediately with full implementation by July 1, 2021. Subject to the Solicitor's approval. This motion was seconded by Mr. Madden and carried with an abstention vote being registered by Mr. Zidek.

Motion made by Dr. Taylor to Amend the term of Professional Services Agreement with Marianne Jackson to provide services as the Interim Director of Elections to begin January 1, 2021 instead of February 1, 2021. All other terms of the Agreement remain the same. Subject to Solicitor's approval. This motion was seconded by Ms. Schaefer and carried unanimously.

Motion made by Dr. Taylor approving to Amend the term of Professional Agreement with Christina Perrone to provide project management services in relation to the May Primary Election, improvements to the Medical Examiner's facilities and operations, formation of the County Health Department, and other initiatives to begin January 1, 2021 instead of February 1, 2021. All other terms of the Agreement remain the same. Subject to Solicitor's approval. This motion was seconded by Mr. Madden and carried unanimously.

The generator and support equipment will provide portable electric lighting and power for ancillary support equipment for the COVID task force mass vaccination site at Delaware County Community College. Executive Director: Mr. Lazarus stated that we will have many items coming forward in the upcoming months including the deprivatization of the prison, Health Department, Medical Examiner's office and the 2022 Budget. Mr. Lazarus also spoke on current and estimated costs for the Wellness Center in Yeadon.

Solicitor: Mr. Martin asked for Council's authorization to file two (2) Terminations of Parental Rights and one (1) Consent for Adoption with the Orphans Court.

Motion made by Mr. Madden approving to file to file two (2) Terminations of Parental Rights and one (1) Consent for Adoption with the Orphans Court, seconded by Ms. Reuther and carried unanimously.

Mr. Martin gave an update on the Rental Assistance Program.

PUBLIC COMMENT: Kelly Diaz, 1119 Morton Avenue, Folsom, PA made a comment regarding the position of the County Treasurer.

COUNCIL: Ms. Schaefer spoke regarding moving forward with Council's initiatives such as the compensation study, 911 Center moving forward, electrifying our fleet, and our Health Department. Ms. Schaefer is very excited that we are making progress with out initiatives.

Mr. Zidek spoke regarding the Covanta incinerator contract that will be entered into by the Solid Waste Authority. We have been informed that there is going to be a public meeting, but we do not know when that meeting will take place. We encourage all residents that are interested in this topic, please keep an eye out for the public meeting.

There being no further County business, nor public discussion, motion made by Mr. Madden to adjourn the meeting, seconded by Ms. Reuther and carried unanimously.
