This is a non-competitive grant in the amount of \$670,885.00 to secure state funds that are being made available to support Delaware County for the costs incurred for supervising adult offenders. Motion made by Dr. Taylor approving to Amend Professional Services Agreement with Gorenflo Consulting, Inc. for an increase of \$37,250.00 for assistance in preparing a strategic plan for a proposed County Health Department, in an amount not to exceed \$82,250.00. Subject to the Solicitor's approval. The motion was seconded by Mr. Madden and carried unanimously.

Motion made by Dr. Taylor approving to Award Request for Proposal to Michigan Election Services for the May 2021 Primary Ballot printing and by mail fulfillment in an estimated cost of \$115,000.00. Subject to Solicitor's approval. The motion was seconded Ms. Schaefer and carried unanimously.
