# Unofficial Notice of Election for Military and Overseas Voters County of DELAWARE

Municipal Primary May 20, 2025

This is an unofficial notice of the Primary Election to be conducted on May 20, 2025, in Delaware County. You may register to vote and request an official absentee ballot by using the Federal Post Card Application (FPCA), available at <a href="www.votespa.com">www.votespa.com</a> or <a href="www.votespa.com">www.fvap.gov</a>. You may apply for an absentee ballot by submitting your FPCA by fax to (610) 892-0641 or by email to <a href="www.uocava@co.delaware.pa.us">www.uocava@co.delaware.pa.us</a>

You may request an absentee ballot from this office at any time prior to a Primary or Election. However, if time does not permit you to receive and return an official absentee ballot, you are also entitled to vote using the Federal Write-in Absentee Ballot (FWAB). Military electors may also use the FWAB to register to vote and vote simultaneously.

You may use the FWAB to vote all federal, state and local offices, and ballot initiatives.

To vote, fill out and send in the **Voter Information Page** (page 2) and **Official Backup Ballot** (page 3) of the FWAB.

- To vote for state and local offices or for ballot initiatives write the names of candidates or the ballot initiative in the appropriate section of the FWAB.
  - Under the Office/Ballot Initiative heading, enter the office the candidate is running for or the title of the Ballot Initiative (referendum).
  - Under the Candidate Name, Party Affiliation or Initiative Vote heading, list the name of the candidate you wish to vote for, or if you are voting on a Referendum question write "yes" or "no."

THIS NOTICE IS UNOFFICIAL AND WILL BE UPDATED WITH OFFICES AND CANDIDATE NAMES WHEN THEY BECOME AVAILABLE.
THE NOTICE MUST BE CONSULTED REGULARLY BECAUSE OF THE POSSIBILITY THAT CANDIDATE LISTS MAY CHANGE.
