GENERAL RULES, REGULATIONS & CONDITIONS OF SUPERVISION (*Specialized*)

Juvenile Court Supervision is ordered. I am now under the jurisdiction and supervision of the Delaware County Juvenile Court. I shall remain under the jurisdiction and supervision of the Court until further Order of court terminating my supervision or I attain the age of Twenty-One (21) years of age. While under the Jurisdiction and supervision of Juvenile Court I shall follow and abide by the following general rules, regulations, terms and conditions. If a violation of any of the terms and conditions set forth below occurs, the Court may modify the disposition at any time.

In addition to any other Court ordered conditions, I, _____, shall abide by and be subject by the terms and conditions set forth below. I acknowledge receipt of this form and that I have read and understand each of the following terms and conditions. I further understand I am subject to and required to follow the following rules, regulations, terms and conditions. I must:

- _____ Comply with all federal, state, county & municipal laws and/or ordinances.
- _____ Comply with the municipal curfew; unless an earlier curfew is set by the Court, the Probation Department, or the parent/guardian.
- _____ Notify the assigned Juvenile Probation Officer within twenty-four (24) hours of any contact with law Enforcement involving an investigation where I am a victim, witness or alleged offender.
- _____ Refrain from any illegal or illicit behavior which threatens or endangers my safety or the safety of others. Any such behavior will be promptly addressed by Probation and/or the Court.
- _____ Submit to police processing (Fingerprint/Photograph) and/or DNA (Fingerprints) as statutorily obligated.
- _____ If mandatory school age, I shall make every effort to attend school. If I have an unexcused absence from school or any disciplinary problem(s), I must report the unexcused absence and/or disciplinary problem or incident to the Probation Department within forty-eight (48) hours.
- _____ Not travel outside the state for more than twenty-four (24) hours without first obtaining permission from the Juvenile Probation Department.
- _____ Report any change of address, phone number, school, or employment to Probation. If my family plans to move, I shall provide my new address and phone number to Probation before the move. If I am moving out of the county/state, I shall provide my new address and other relevant information to Probation at least thirty (30) days in advance.

GENERAL RULES, REGULATIONS & CONDITIONS OF SUPERVISION *(continued)*

_____ If I have been ordered to have **No Contact, No Inappropriate Contact, or No Unsupervised Contact** with the victim(s) and/or co-offender(s), **No contact** means no contact by any means, including direct contact by person, letter/note, email, text, telephone/cellphone, or any form of social media, e.g., Facebook, Snapchat, Twitter, etc. OR indirect contact through another person. **No Inappropriate Contact** means no contact with the other person without a legitimate & lawful purpose. **No Unsupervised Contact** means no contact with the individual(s) without an approved supervising adult.

_____ Remain drug and alcohol-free. Drug and alcohol testing can occur anytime. Abstain from the unlawful possession or sale of narcotics and drugs and abstain from using controlled substances within the meaning of the Controlled Substance, Drug, Device, and Cosmetic Act (35P.S. 780-101 et, Seq., as amended to date) without a valid prescription, Drug and alcohol testing can occur through urine, saliva, and breathalyzer testing.

_____ Refrain from owning, or possessing any firearm, deadly weapon or offensive weapon, including any real or fake firearm or weapon — including BB and toy guns. The term "fake" as used herein includes BB guns, model guns or weapons and/or toy guns or weapons.

If my parent or guardian owns or possesses a firearm the Juvenile Probation Department must be notified. I understand that the firearm must be legal and registered as well as properly secured at all times I am in the home and/or anywhere the firearm may be present. I have made my parent and/or guardian aware of this term and condition.

I am prohibited from being in the presence of any illegal or unlicensed firearm (real or fake) or deadly weapon during the term of my supervision. I understand I must remove myself from the presence of any unsecured, unlicensed or unregistered firearm or deadly weapon, I further understand that I am prohibited from being and must remove myself from the presence of anyone possessing an illegal, unlicensed or unregistered firearm.

I am prohibited from posing with any firearm real or fake at any time and/or posting on social media any photographs of a firearm or weapon real or fake.

_____ Cooperate with any request by Probation to search my person or property. I am subject to being searched by Probation at any time subject only to the reasonable limits of 42 PA.C.S.A § 6304, (Authority to search Person and Property). A personal search is defined as a warrantless search of a child's person, including, but not limited to, the child's clothing and any personal property which is in the possession, within the reach or under the control of the child. A property search is defined as a warrantless search of real property, vehicle or personal property which is in the possession or under the control of a child — including electronic devices.

_____ Call and/or report to my Probation Officer as directed. Supervision and counseling may occur at any location as arranged by the Probation Department. I must allow Probation or any service provider access to and/or to visit my residence, school, or place of employment at any time. If I need to reschedule an appointment or visit, I must notify my Probation Officer directly and request to reschedule the visit or appointment.
