*The below captions are a summary of significant police responses during the listed week. The blotter does not include all calls for service attended to by the Delaware County Park Police Department.

• 10/08/2023 10:55 AM, (County Park Ordinance Violation)

Officers assigned to Parks Patrol observed a vehicle enter Upland Park through the main entrance and fail to stop at a stop sign. Officers conducted a traffic stop and advised the driver of the vehicle of the County Park Ordinance Violation before releasing them with a citation.

Officers assigned to Parks Patrol received notification of a dog attack that had occurred at Rose Tree Park. Officers made contact with the complainant and were advised that an individual with their dog off of its leash had approached the complainant and the complainant asked if they could pet the dog. While petting the dog the dog reportedly bit a child that was with the complainant causing the need for the child to go to the hospital. Due to the need for the child to go to the hospital the complainant did not obtain any information from the dog owner before leaving the scene. Following this, officers forwarded all obtained information to the Investigations Division in an attempt to investigate the incident and find the dog and owner. Detectives were able to locate the owner and obtain all needed information needed to conclude the investigation.
