WEEKLY POLICE BLOTTER 10/15/2023 – 10/21/2023

*The below captions are a summary of significant police responses during the listed week. The blotter does not include all calls for service attended to by the Delaware County Park Police Department.

• 10/15/2023 6:57 PM, (Disturbances)

Officers assigned to Parks Patrol received a call for a large group fighting in Upland Park. Delaware County Park Police Officers as well as Upland Borough, Chester Township, and Chester City Police Officers responded to the call. Upon arrival officers broke up a large crowd of 100-200 individuals and detained individuals suspected of fighting and causing a disturbance. Once officers cleared the park out the individuals that were detained were identified, issued warnings, and released.

• 10/16/2023 1:01 PM, (Disturbances)

Officers assigned to the Courthouse Complex received a call for a disturbance outside of one of the offices inside of the courthouse. Arriving officers found two individuals that reportedly had a verbal argument. Officers separated and gathered information from both individuals before escorting them out of the facility separately.

• 10/16/2023 09:10 AM, (Damage to County Property)

Officers assigned to Parks Patrol discovered a broken window in a building on the Don Guanella property. Officers searched the building and found no evidence of anyone inside or around the property. The damage was documented and forwarded to the Investigations division for further investigation and the Parks Department was notified to repair the damage.

• 10/16/2023 2:49 PM, (Narcotics – Possession – Marijuana)

Officers assigned to the Chester Probation Office found a zip lock bag containing what appeared to be marijuana and was labeled as cannabis while screening an individual into the building. Officers confiscated the bag and contents and advised the individuals probation officer to determine how they wanted to move forward with the officer's findings. The individual was issued a warning and the bag and contents were confiscated and submitted as evidence to be destroyed.

• 10/17/2023 11:50 AM, (Wanted Person)

Officers assigned to Upper Darby Probation detained and arrested an individual with an active Violation of Probation warrant.

Officers assigned to Upper Darby Probation detained and arrested an individual with an active Violation of Probation warrant.

• 10/17/2023 6:30 PM, (Medical Emergency)

• 10/18/2023 12:35 PM, (Panic/Silent Alarms)

Officers assigned to the Courthouse Complex received a report of a panic alarm in one of the courtrooms in the courthouse. Arriving officers found an individual who claimed to have been harassed by another individual in the area. Officers took information and advised the accused individual to stay away from the other party.

Officers assigned to Chester Probation detained and arrested an individual with an active Violation of Probation warrant.

• 10/18/2023 10:13 PM, (Medical Emergency)

Officers assigned to the Fair Acres Division received a call for a medical emergency in Building 8. Officers assisted the Riddle Memorial Hospital (RMH) ambulance paramedics in locating the subject in need of medical care and then assisted in escorting the paramedics back to their ambulance for transport of the patient.

• 10/19/2023 10:49 PM, (Medical Emergency)

Officers assigned to the Fair Acres Division received a call for a medical emergency in Building 6. Officers assisted the Riddle Memorial Hospital (RMH) ambulance paramedics in locating the subject in need of medical care and then assisted in escorting the paramedics back to their ambulance for transport of the patient.

• 10/19/2023 12:23 PM, (Forgery)

Officers assigned to the Courthouse Complex received a call from the Financial Services Office within the courthouse for a report of a forgery occurring. Arriving officers met with an individual who claimed to have had their signature forged onto court documents previously. Officers collected information and forwarded it to the Investigations Division to follow up on the report.

• 10/20/2023 1:05 PM, (Assaults – Simple)

Officers assigned to the Courthouse Complex received a call for a group of individuals fighting inside of the courthouse. Upon arrival officers separated the parties involved and gathered information. Assisting sheriff's deputies advised that they observed an assault take place between two of the individuals via their surveillance cameras. Officers gathered the evidence and forwarded it to the Investigations Division for further investigation into the matter.

• 10/20/2023 2:41 PM, (Panic/Silent Alarms)

Officers assigned to the Courthouse Complex received a report of a panic alarm in one of the offices in the courthouse. Upon arrival officers found two individuals who had allegedly been involved in a verbal altercation. Officers separated the two and gathered their information before escorting them out of the courthouse through separate exits.

• 10/21/2023 2:00 PM, (Indecent Exposure)

Officers assigned to Parks Patrol found an individual within Rose Tree Park urinating between vehicles. Officers stopped and detained the individual were advised that the individual could not find a nearby bathroom fast enough. Officers advised the individual that it was still against the county park ordinance and the law to urinate in public. The individual was issued a citation before being released.
