WEEKLY POLICE BLOTTER 11/05/2023 – 11/11/2023

*The below captions are a summary of significant police responses during the listed week. The blotter does not include all calls for service attended to by the Delaware County Park Police Department.

• 11/06/2023 08:13 AM, (County Park Ordinance Violation)

Officers assigned to Parks Patrol observed a vehicle enter Rose Tree Park through the main entrance and cut through the park to the side entrance before exiting to Rose Tree Road. Officers conducted a traffic stop and advised the driver of the vehicle of the County Park Ordinance Violation before releasing them with a citation.

• 11/06/2023 1:25 PM, (Wanted Person)

Officers assigned to Chester Probation detained and arrested an individual with an active Violation of Probation warrant.

• 11/07/2023 7:22 PM, (Expired Registration)

Officers assigned to Parks Patrol observed a vehicle enter Clayton Park through the side entrance with what appeared to be expired registration stickers being displayed on it. Officers conducted a traffic stop and confirmed that the stickers were in fact expired. Officers issued the driver a citation before releasing them.

Officers assigned to Parks Patrol observed a vehicle enter Rose Tree Park through the main entrance and cut through the park to the side entrance before exiting to Rose Tree Road. Officers conducted a traffic stop and advised the driver of the vehicle of the County Park Ordinance Violation before releasing them with a citation.

• 11/08/2023 12:47 PM, (Wanted Person)

Officers assigned to Upper Darby Probation detained and arrested an individual with an active Violation of Probation warrant.

• 11/08/2023 2:02 PM, (Panic/Silent Alarms)

Officers assigned to the Courthouse Complex received a report of a panic alarm inside of one of the offices in the courthouse. Arriving officers found the alarm to be an accidental activation.

• 11/08/2023 2:53 PM, (Wanted Person)

Officers assigned to Chester Probation detained and arrested an individual with an active Violation of Probation warrant.

• 11/09/2023 12:19 AM, (Medical Emergency)

Officers assigned to the Fair Acres Division received a call for a medical emergency in Building 8. Officers assisted the Riddle Memorial Hospital (RMH) ambulance paramedics in locating the subject in need of medical care and then assisted in escorting the paramedics back to their ambulance for transport of the patient.

• 11/09/2023 10:00 AM, (Abandoned Vehicle)

Officers assigned to Parks Patrol received a report of a possible abandoned vehicle inside of Upland Park. Arriving officers located the reported vehicle and began gathering information on the vehicle. A vehicle identification number (VIN) showed the vehicle to be unregistered. Officers contacted a tow company to remove the vehicle from the park before clearing the scene.

• 11/09/2023 10:13 AM, (Wanted Person)

Officers assigned to Upper Darby Probation detained and arrested an individual with an active Violation of Probation warrant.

• 11/09/2023 12:50 PM, (Disturbances)

Officers assigned to the Courthouse Complex received a call for a disturbance outside of the main courthouse doors. Arriving officers found two individuals engaged in a verbal argument. Officers separated and gathered information from both individuals to deescalate the situation and gather information on both parties involved. Officers calmed the involved parties down and allowed them to leave the scene separately after being issued warnings.

• 11/09/2023 5:14 PM, (Disturbances)

Officers assigned to the Courthouse Complex received a call for a disturbance outside of the main courthouse doors. Arriving officers found multiple individuals engaged in a verbal argument. Park Police Officers as well as Sheriff's Deputies separated the individuals that were arguing and gathered information about the incident. It was determined that a physical altercation had not occurred, and all individuals released from the scene with warnings.

• 11/10/2023 12:02 PM, (County Park Ordinance Violation)

Officers assigned to Parks Patrol were dispatched to the Don Guanella Property for a report of an individual dressed in camouflage carrying what appeared to be a rifle into the wooded area of the property. Park Police Officers as well as Marple Township Police Officers arrived on scene to find a vehicle parked at the wood line with camouflage articles inside of it in plain sight. Officers observed the area for a short time until the individual dressed in camouflage emerged from the woods carrying a hunting bow and returned to the vehicle. Officers initiated contact and questioned the individual as to what they were doing in the woods. The individual advised officers that they were not aware that hunting was prohibited or that they were on county owned property. Officers gathered the individual's information and issued them a citation before clearing the scene.

• 11/11/2023 05:50 AM, (911 – Hang-Up)

Officers assigned to the Delaware County Park Police Dispatch Desk received a call from the Delaware County 911-Center for a report of a 911 hang-up at the George W. Hill Correctional Facility with no call back info given. Officers contacted the George W. Hill Correctional Facility Shift Commander and were advised that there were no issues at that time.
