WEEKLY POLICE BLOTTER

\*The below captions are a summary of significant police responses during the listed week. The blotter does not include all calls for service attended to by the Delaware County Park Police Department.

#### • 11/20/2023 3:41 PM, (Disturbances)

Officers assigned to the Courthouse Complex received a call for a disturbance outside of the courthouse. Arriving officers found two individuals who were engaged in a verbal altercation. Officers separated the parties and collected information before releasing them and advising them to go separate ways off the property.

#### • 11/20/2023 11:30 PM, (911 - Hang Up)

Officers assigned to Parks Patrol received a call for a 911 hang up at Rose Tree Park. Arriving officers checked the building from which the call came from and found nobody inside or around it needing help. Officers remained on scene for a short time to ensure everything was ok before clearing from the scene.

Officers assigned to the Upper Darby Probation Office found two bags containing what appeared to be marijuana while screening an individual into the building. Officers confiscated the bags and contents and advised the individuals probation officer to determine how they wanted to move forward with the officer's findings. The individual was issued a warning and the bags and contents were confiscated and submitted as evidence to be destroyed.

Officers assigned to the Delaware County Park Police Dispatch Desk received a call from the Delaware County 911-Center for a report of a 911 hang-up inside of one of the buildings at Rose Tree Park. Arriving officers conducted a search of all buildings and found no one in need of help. Officers were able to narrow down the location the call came from to a phone line located across Rose Tree Road on the now abandoned Sunoco property. This information was relayed back to the Delaware County 911-Center who will be in touch with Verizon to look into the issue.
