*The below captions are a summary of significant police responses during the listed week. The blotter does not include all calls for service attended to by the Delaware County Park Police Department.

Officers assigned to the Fair Acres Division received a call for a medical emergency in Building 8. Officers assisted the Riddle Memorial Hospital (RMH) ambulance paramedics in locating the subject in need of medical care and then assisted in escorting the paramedics back to their ambulance for transport of the patient.

Officers assigned to the Courthouse Complex were dispatched to a disturbance outside of one of the courtrooms. Arriving officers found an individual that had reportedly been engaged in a verbal altercation with some of the court staff. All individuals were separated, information was obtained, and officers released the individual to go back to the courtroom after confirming with court staff that their case would continue. Officers stood by to ensure no further incidents occurred.

Officers assigned to Upper Darby Probation detained and arrested an individual with an active Violation of Probation warrant.
