Weekly Police Blotter

*The below captions are a summary of significant police responses during the listed week. The blotter does not include all calls for service attended to by the Delaware County Park Police Department.

- **02/06/2023 10:10 AM, (Medical Emergency)**
Officers assigned to the Fair Acres Division received a call for a medical emergency in Building 8. Officers assisted the Riddle Memorial Hospital (RMH) ambulance paramedics in locating the subject in need of medical care and then assisted the paramedics back to their ambulance for the transport of the patient.
- **02/06/2023 11:40 AM, (Domestic Dispute)**
Officers assigned to the Courthouse Complex observed a verbal altercation in front of the courthouse complex. Officers separated and spoke with both parties who advised they were there for court and were leaving when the dispute occurred. Both parties were separated and left the scene in separate vehicles.
- **02/06/2023 3:01 PM, (Wanted Person)**
Officers assigned to the Sharon Hill Division detained and arrested an individual with an active violation of probation warrant.
- **02/07/2023 4:11 PM, (Vehicle Accident)**
Officers assigned to the Fair Acres Division responded to a report of a vehicle accident with injuries. Upon arrival, officers found a two-vehicle accident with both drivers reporting no injuries. Officers

remained on scene providing traffic safety until the tow company arrived to remove both vehicles.

Officers assigned to the Chester Division arrested an individual with an active criminal warrant.
- **02/07/2023 10:33 PM, (Attempted Theft)**
Officers assigned the Courthouse Complex observed an individual loading wooden pallets onto a flatbed trailer from the Courthouse loading dock area. Upon contacting the individual, officers found that the individual was not an employee and was not permitted to remove anything from that area. Officers obtained the individual's information, advised him to put the pallets back and the individual was issued a warning.

Officers assigned to the Courthouse Complex received a call for a possible medical emergency in one of the courtrooms. Officers responded and determined that an ambulance was needed. Officers assisted the Paramedics once on scene and the subject in need of care was transported to the hospital for further care.

Officers assigned to Parks Patrol came in contact with a dog owner in Rose Tree Park with their dog off of its leash. The owner was advised of the county leash ordinance and was issued a warning.
