*The below captions are a summary of significant police responses during the listed week. The blotter does not include all calls for service attended to by the Delaware County Park Police Department.

• 04/02/2023 4:03 PM, (Suspicious Person)

Officers assigned to the Parks Patrol received a report of a person looking through vehicle windows at the Knowlton Rd. Chester Creek Trails parking lot. Arriving officers found the person to be gone upon their arrival and the information was passed to detectives in the Investigations Division for follow up.

Officers assigned to Upper Darby Probation detained and arrested an individual with an active Violation of Probation warrant.

• 04/06/2023 9:15 PM, (Assist Other Agencies)

Officers assigned to the Park Police Department Dispatch Desk received a call regarding a person requesting a wellness check on a coworker. Officers collected the information and passed it to the police department where the person lives.

Officers assigned to Parks Patrol found a downed tree while on patrol on the Little Flower Manor property. The officers contacted the Parks Department to assist in removing the tree.
