### WEEKLY POLICE BLOTTER

04/30/2023 – 05/06/2023

\*The below captions are a summary of significant police responses during the listed week. The blotter does not include all calls for service attended to by the Delaware County Park Police Department.

#### **• 04/30/2023 6:09 PM, (Criminal Mischief)**

Officers assigned to Parks Patrol found a broken exterior window on one of the buildings within the Don Guanella Property. Officers checked to ensure the building was still secure and noted the found damage for future shifts.

#### **• 04/30/2023 10:14 PM, (Open Doors/Windows – Discovered)**

Officers assigned to Parks Patrol found an unlocked door during a check of the buildings within Smedley Park. Officers did a check of the building and re secured the door.

**• 05/06/2023 6:17 PM, (Assist Other Agencies – Fire Dept.)**

Officers assigned to Parks Patrol observed an individual's vehicle leaving a heavy trail of smoke from behind of it. After the vehicle pulled over officers assisted the vehicles driver by contacting the Fire Department to respond to assist. The individual was attempting to get the car to a mechanic just down the street from where they stopped. Upon arrival, Chester Township Officers advised that the individual could drive the vehicle the rest of the way if they could make it. Following this all police and Fire Department units cleared the scene.
