# WEEKLY POLICE BLOTTER

#### • 06/25/2023 6:30 PM, (Special Detail)

Delaware County Park Police Officers assisted in traffic control and crowd safety during the Rose Tree Park summer festival concert series.

No occupants were found at that time and the building was re-secured.

## • 07/01/2023 6:47 PM, (Harassment)

Arriving officers found there to have been a domestic incident between two parties stemming from a custody exchange. Officers observed damage to the complainant's vehicle consistent with observed injuries to the accused party in the matter. Officers arrested the accused party and transported them to the hospital to be treated before bringing them back to Park Police Headquarters to be housed and processed.
