### WEEKLY POLICE BLOTTER

08/20/2023 – 08/26/2023

\*The below captions are a summary of significant police responses during the listed week. The blotter does not include all calls for service attended to by the Delaware County Park Police Department.

#### **• 08/20/2023 5:48 PM, (Noise Complaint)**

Officers assigned to Parks Patrol were dispatched to Smedley Park for a report of a noise complaint within the park. Arriving officers met with an individual who displayed a park permit that allowed them to have a party at that location. Officers advised the individual to keep the volume of their music down and they complied.

#### **• 08/21/2023 2:33 PM, (Disturbances)**

Officers assigned to the Courthouse Complex received a call for a disturbance outside of the one of the offices inside of the complex. Arriving officers met with an individual that was causing the disturbance and calmed them down. After speaking with the individual officers escorted them out of the building without further incident.

**• 08/21/2023 3:35 PM, (Disorderly Conduct)**

Officers assigned to Parks Patrol were dispatched to the Marple Incinerator for a report of an assault. Arriving officers met with Marple Township Police Department Officers who also responded to assist. Officers were advised that employees from a trash company dropping off trash at that location had been involved in an incident that involved objects being thrown at one of the reporting parties. The person suspected of throwing the objects had already left the scene prior to police arrival and due to no injuries being reported all parties were advised to pursue the matter with Marple District Court if they wished to have a Private Criminal Complaint initiated.

**• 08/21/2023 4:01 PM, (County Park Ordinance Violation)**

Officers assigned to Parks Patrol found swimmers in the water at Kent Park during a routine patrol of the park. Officers advised the swimmers to exit the water and informed them that swimming is prohibited there due to the safety issues and no lifeguard being present. The swimmers were issued citations and released.

Officers assigned to the 69<sup>th</sup> street CYS office were called by employees regarding a visitor that would not stop pressing the doorbell for the office. Arriving officers advised the person that office hours end at 4:30PM and they would not be able to be seen today. The individual advised officers that they would not be leaving the property until they spoke with CYS. Officers advised the individual that they could be detained and possibly criminally charged if they continued to refuse to leave. Following this the individual left without further incident.
