WEEKLY POLICE BLOTTER

10/13/2024 – 10/19/2024

*The below captions are a summary of significant police responses during the listed week. The blotter does not include all calls for service attended to by the Delaware County Park Police Department.

• 10/13/2024 09:36 AM, (Medical Emergency)

Officers assigned to the Fair Acres Division received a call for a medical emergency in Building 8. Officers assisted the Riddle Hospital ambulance paramedics in locating the subject in need of medical care and then assisted in escorting the paramedics back to their ambulance with the patient for transport.

• 10/13/2024 12:10 PM, (Building Checks)

Officers assigned to Parks Patrol were dispatched to the Delco Woods Property for a report of vandalism to one of the buildings. Arriving Officers documented the damage and contacted the Parks Department to assess and fix the reported damage.

• 10/14/2024 11:07 AM, (Wanted Person)

Officers assigned to the Chester Probation Office detained and arrested an individual with an active Violation of Probation warrant.

• 10/14/2024 4:18 PM, (County Park Ordinance Violation)

Officers assigned to Parks Patrol observed a vehicle enter Rose Tree Park through the main entrance and cut through the park to the side entrance before exiting to Rose Tree Road. Officers conducted a traffic stop and advised the driver of the vehicle of the County Park Ordinance Violation before issuing a citation and releasing them.

Officers assigned Parks Patrol were dispatched to Upland Park for a report of a disorderly group within the park. Upland Borough Police Department Officers arrived at the park and advised that the reported group appeared to have left the area. Upon arrival, Park Police Officers conducted another search of the park to confirm that the reported group had left prior to police arrival. Officers remained on location for a short time to ensure the group did not return.

• 10/15/2024 12:00 PM, (Narcotics – Possession – Marijuana)

Officers assigned to the Courthouse Complex found what appeared to be a small container of marijuana inside of an individual's belongings while screening them into the building. The individual advised that they did not have a valid medical marijuana card and was issued a warning as well as the marijuana being confiscated and submitted to be destroyed.

Officers assigned to the Courthouse Complex responded to a report of a disturbance inside of one of the offices. Arriving officers met with an individual who claimed they had reportedly been causing the disturbance but had calmed down upon officers' arrival. Officers assigned to the Upper Darby Probation Office detained and arrested an individual with an active Violation of Probation warrant.

• **10/18/2024 10:54 AM, (Panic Alarms)**
