WEEKLY POLICE BLOTTER

11/03/2024 – 11/09/2024

*The below captions are a summary of significant police responses during the listed week. The blotter does not include all calls for service attended to by the Delaware County Park Police Department.

• 11/03/2024 1:35 PM, (Disturbances)

Officers assigned to Parks Patrol responded to a report of an individual creating a disturbance at the Delaware County Emergency Services Training Center. Arriving officers met with the complainant who advised that the individual in question had already left. Officers gathered information and a statement from the complainant and remained on location for a short time to ensure the individual did not return.

• 11/03/2024 9:00 PM, (County Park Ordinance Violation)

Officers assigned to Parks Patrol observed a vehicle parked in the parking area of Little Flower Park afterhours. Upon a further investigation officers found the vehicle to be occupied and conducted a traffic stop on the vehicle. The driver was advised of the county park ordinance violation and issued a citation before being released.

• 11/04/2024 08:49 AM, (Weapons Possession)

Officers assigned to the screening area of the Courthouse Complex located and confiscated a taser being carried by an individual checking into the facility. The individual was advised that tasers are prohibited weapons and was issued a warning.

• **11/04/2024 1:16 PM, (Medical Emergency)**

Officers assigned to the Chester Probation Office observed an individual lose consciousness shortly after their arrival to the office. Officers determined the individual was suffering from a possible overdose and administered Narcan nasal spray and called for an ambulance. The individual was stabilized and transported to Cozer-Chester Medical Center via the ambulance.

• **11/04/2024 7:19 PM, (Medical Emergency)**

Officers assigned to the Fair Acres Division received a call for a medical emergency in Building 8. Officers assisted the Riddle Hospital ambulance paramedics in locating the subject in need of medical care and then assisted in escorting the paramedics back to their ambulance with the patient for transport.

• **11/04/2024 7:31 PM, (County Park Ordinance Violation)**

Officers assigned to Parks Patrol observed a vehicle parked in the rear of Smedley Park afterhours. Upon a further investigation officers found the vehicle to be occupied and conducted a traffic stop on the vehicle. The driver and passenger were advised of the county park ordinance violation and issued warnings before being released.

• **11/06/2024 10:36 AM, (Wanted Person)**

Officers assigned to Chester District Court detained and arrested an individual with an active county bench warrant.

• **11/06/2024 11:57 AM, (Panic Alarms)**

Officers assigned to the Courthouse Complex responded to a report of a panic alarm in one of the courtrooms in the complex. Arriving officers met with two individuals who had previously been arguing but were calm at that time. Officers gathered the individual's information and remained on location for the court proceedings to be completed before escorting them out of the complex through separate exits.

• **11/06/2024 1:37 PM, (Wanted Person)**

Officers assigned to Chester District Court detained and arrested an individual with an active county bench warrant.

• **11/07/2024 11:43 PM, (Medical Emergency)**

Officers assigned to the Fair Acres Division received a call for a medical emergency in Building 8. Officers assisted the Riddle Hospital ambulance paramedics in locating the subject in need of medical care and then assisted in escorting the paramedics back to their ambulance with the patient for transport.

• **11/08/2024 2:30 PM, (Wanted Person)**

Officers assigned to the Chester Probation Office detained and arrested an individual with an active Violation of Probation warrant.

• **11/09/2024 4:15 PM, (County Park Ordinance Violation)**

Officers assigned to Parks Patrol were dispatched to Upland park for a report of two individuals dressed in camouflage and hunting in the park. Officers were not able to make contact with the individuals but were able to identify them after Chester Township Police Department Officers towed their vehicle due to it being parked on private property. The individuals were mailed citations for county park ordinance violations.
