WEEKLY POLICE BLOTTER 02/25/2024 – 03/02/2024

\*The below captions are a summary of significant police responses during the listed week. The blotter does not include all calls for service attended to by the Delaware County Park Police Department.

### • 02/25/2024 12:12 PM, (Audible Burglary Alarm)

Officers assigned to Parks Patrol were dispatched to Don Guanella for a report of an audible burglary alarm sounding in the complex. Arriving officers searched the area and found nothing out of the ordinary. The alarm was reset, and officers cleared after ensuring no one else was on the property.

Officers assigned to the Courthouse Complex responded to a panic alarm activation in one of the offices inside of the complex. Arriving officers had discovered that the activation had been accidental, and no help was needed.

## • 02/27/2024 2:01 PM, (Medical Emergency)

Officers assigned to the Fair Acres Division received a call for a medical emergency in Building 8. Officers assisted the Riddle Hospital ambulance paramedics in locating the subject in need of medical care and then assisted in escorting the paramedics back to their ambulance after the patient refused transport.

### • 02/27/2024 3:04 PM, (Drug Paraphernalia)

Officers assigned to the Parks Patrol were dispatched to a report of a subject down in the area of Glen Providence Park. Arriving officers located and escorted the individual from the woods of the park out to the street where the individual was then questioned. The individual was found to have had a bag full of drug paraphernalia and was subsequently charged, arraigned, and transported to the Delaware County Prison by officers.

Officers assigned to Sharon Hill Probation detained and arrested an individual with an active Violation of Probation warrant.

### • 02/28/2024 10:03 AM, (Panic Alarm)

Officers assigned to the Courthouse Complex responded to a panic alarm activation in one of the offices inside of the complex. Arriving officers met with an individual who had been arguing with the county employee at the filing window prior to the officer's arrival. Officers de-escalated the situation and escorted the individual out of the office and took a statement from them regarding the matter.

Officers assigned to Upper Darby Probation detained and arrested an individual with an active Violation of Probation warrant.

## • 02/29/2024 3:50 PM, (Wanted Person)

Officers assigned to the Courthouse Complex were dispatched to one of the offices in the complex for a report of an individual with a possible warrant for their arrest. Arriving officers detained the individual and confirmed the warrant before taking them into custody and transporting them to the agency they were wanted by.

## • 03/01/2024 1:50 PM, (Counterfeit Currency)

Officers assigned to the Courthouse Complex were dispatched to one of the offices in the complex for a report of an individual making having a possible counterfeit bill mixed in with their money at one of the payment windows. Arriving officers obtained the currency in question and confirmed it was counterfeit. The individual was questioned and denied any knowledge of the bill being counterfeit. The individual's information was obtained and their info and the currency was forwarded to the U.S. Secret Service for review and investigation.

# • 03/01/2024 2:30 PM, (Narcotics – Possession – Prescription Med)

Officers assigned to the Courthouse Complex found a bag with what appeared to be prescription medication inside while screening an individual into the building. The individual possessing the medication was not the prescribed user. The individual was advised that the prescribed person is the only authorized person to possess the medication and it would be held in police custody until that person arrived to obtain it. The individual was issued a warning before being released.

Officers assigned to the Fair Acres Division received a call for a medical emergency in Building 6. Officers assisted the Riddle Hospital ambulance paramedics in locating the subject in need of medical care and then assisted in escorting the paramedics back to their ambulance with the patient for transport.
