### WEEKLY POLICE BLOTTER

06/23/2024 – 06/29/2024

\*The below captions are a summary of significant police responses during the listed week. The blotter does not include all calls for service attended to by the Delaware County Park Police Department.

#### **• 06/23/2024 3:37 PM, (County Park Ordinance Violation)**

Officers assigned to Parks Patrol found swimmers in the water at Kent Park during a routine patrol of the park. Officers advised the swimmers to exit the water and informed them that swimming is prohibited there due to the safety issues and no lifeguard being present. The swimmers were issued citations and released.

#### **• 06/23/2024 3:55 PM, (County Park Ordinance Violation)**

Officers assigned to Parks Patrol observed individuals in the water swimming in the water at Kent Park and consuming alcoholic beverages. Officers advised the swimmers to exit the water and informed them that swimming and consumption of alcohol in the county parks is prohibited there due to the safety issues that arise for those situations. The swimmers were issued citations for the county park ordinance violation and released.

#### **• 06/24/2024 11:15 AM, (Disturbances)**

Officers assigned to the Courthouse Complex responded to a report of a disturbance outside of one of the courtrooms inside of the courthouse. Arriving officers met with two individuals who advised that they were engaged in an argument prior to the officer's arrival but the dispute was settled. Officers advised the individuals to keep their voices down while outside of the courtrooms.

• **06/26/2024 6:55 PM, (County Park Ordinance Violation)**

Officers assigned to Parks Patrol found swimmers in the water at Kent Park during a routine patrol of the park. Officers advised the swimmers to exit the water and informed them that swimming is prohibited there due to the safety issues and no lifeguard being present. The swimmers were issued warnings and released.

• **06/27/2024 11:40 AM, (Disputes / Fights)**

Officers assigned to the Courthouse Complex responded to a report of a fight outside of one of the courtrooms inside of the courthouse. Arriving officers met with two individuals in question and obtained witness reports regarding the fight. Both individuals were detained while camera footage was reviewed which did show a physical altercation between the two parties. The aggressor of the altercation was arrested and charged for the incident before being transported to George W. Hill Correctional Facility.

• **06/27/2024 2:24 PM, (Traffic Stop)**

Officers assigned to Parks Patrol observed a vehicle with a paper tag in their window in Kent Park. Officers conducted a traffic stop and spoke with the individual about the tag. Upon running the individual's information, they were found to have an expired license. The individual was issued a citation and advised to call for a ride or walk upon being released.

Officers assigned to Upper Darby Probation detained and arrested an individual with an active Violation of Probation warrant.

• **06/27/2024 7:12 PM, (County Park Ordinance Violation)**

Officers assigned to Parks Patrol found swimmers in the water at Kent Park during a routine patrol of the park. Officers advised the swimmers to exit the water and informed them that swimming is prohibited there due to the safety issues and no lifeguard being present. The swimmers were issued citations and released.

• **06/28/2024 2:48 PM, (Medical Emergency)**

Officers assigned to the Fair Acres Division received a call for a medical emergency in Building 3. Officers assisted the Riddle Hospital ambulance paramedics in locating the subject in need of medical care and then assisted in escorting the paramedics back to their ambulance with the patient for transport.

• **06/29/2024 4:45 PM, (County Park Ordinance Violation)**

Officers assigned to Parks Patrol observed an individual driving their vehicle on the walking trail in Kent Park. The individual was stopped and advised that they had drove past the posted signs advising vehicles weren't permitted on that path. Officers issued the individual a citation before releasing them.

• **06/29/2024 7:48 PM, (Parking Citation)**

Officers assigned to Parks Patrol observed a vehicle partially blocking the roadway and obstructing the flow of traffic in Rose Tree Park. Officers made contact with the assumed owner and advised them to move from where they were parked to which the individual did not and advised officers that they were waiting for someone. Officers then obtained the individuals information as well as the vehicles information and issued a citation for impeding the flow of traffic.
