*The below captions are a summary of significant police responses during the listed month. The blotter does not include all calls for service attended to by the Delaware County Park Police Department.

• <u>05/01/2025 10:10, (Wanted Person)</u>

Officers assigned to Falcon Center Probation detained and arrested a subject with an active warrant. The subject was transported by Constables to the George W. Hill Correctional Facility.

• <u>05/01/2025 20:00, (Fire Alarm)</u>

Officers assigned to the Fair Acres Division responded to a Fire Alarm at Building #6. Officers arrived and determined that it was a false alarm.

• 05/02/2025 10:00, (Wanted Person)

Officers assigned to Sharon Hill Probation detained and arrested a subject with an active warrant. The subject was transported by Constables to the George W. Hill Correctional Facility.

A field test was conducted of the suspected methamphetamine which yielded a positive result. The subject was then transferred to the George W. Hill Correctional Facility by constables.

Officers assigned to the Courthouse Complex were conducting regular screening when they discovered a grinder which contained marijuana residue inside an individual's belongings. The item was confiscated, and the individual was given a warning.
