My son is currently incarcerated at GWH and during most of our calls he discusses what a struggle it is to maintain his sobriety while incarcerated due to the amount of contraband currently on his unit. Though he actively participates in programs and seems to really enjoy them, he's told me that now more than ever the jail is rampant with K2, Suboxone strips and marijuana and having all these things readily available are huge triggers for him. He's even discussed seeing multiple cell phones, all of which he claims have been introduced to the facility by correctional officers in exchange for money on 'cashapp'. My questions are, what is being done to stop the introduction of contraband to the facility by staff? When/if these staff are being caught, are they being prosecuted? I know if my son was caught in the facility with contraband he would be charged. And my last question, is this problem a priority due to all the staffing issues that are reported each month or is it more of a 'a bad CO is better than no CO at all' attitude. We need to hold the security staff accountable for the safety and well-being of our incarcerated family members.
