Consideration of the GEO contract: Mr. Alsayegh provided a brief presentation on the current operations at George Hill. The presentation included GEO Group financials, savings, operational challenges, capital improvements, a county transition plan, transition costs and a proposed transition schedule. The proposed transition schedule estimates county would take over prison operations by April 2022.

Vote to recommend that the County exercise the Termination Clause in its contract with GEO: Motion made by Sheriff Sanders and seconded by Mr. Lazarus. Discussion followed. Vote carried 6-2.

Mary Austin, 1036 First Avenue, Medial PA: Thanked the JOB for taking the first step to de-privatize George W. Hill. Ms. Austin stated that by voting on a partial takeover, the county is not only saving dollars but also the community.

Clifford Brock, 819 Gunther Avenue, Yeadon, PA: Mr. Brock is a member of the Delco CPR and is grateful that the road map has been laid out. Mr. Brock believes that county takeover would be successful with hard work and due diligence.

Jane Dunbar, 232 Garfield Avenue, Norwood, PA: Thanked the JOB for voting on a partial takeover. Ms. Dunbar asked what is a bail setter? Judge Whelan advised that a bail setter does not set bail. Upon review of a criminal case, the bail setter makes a recommendation to the district ministry.

Suzanne Wallace, 929 Harper Avenue, Drexel Hill, PA: Asked if detainees (people with minor probation offenses) are sent to George Hill? Mr. Madden abscised Ms. Wallace that detainees are brought to George W. Hill. Ms. Wallace was welcomed to follow up with further questions once the meeting concludes.

Ms. Phillips made a motion to adjourn seconded by Mr. King. Motion carried unanimously.
