### Lost/Stolen License

In the case of a license that is being reported as stolen, lost or misplaced, the system will produce a new license number and will mark the new permit as “NEW”.

***The original issue and expiration dates remain the same as the original license.***

***The “Replace Lost/Stolen” process automatically revokes the old permit.\****

\*If the old permit is eventually found or returned to the Issuing Authority, this can be noted in the LTC system. The old permit should be destroyed.

### Duplicate License

In the case of a duplicate license because of a name or address change or a damaged license, etc., ***The LTC system will generate a permit with the same permit number, issue and expiration dates.*** The permit will automatically be marked as “Dupl. /Correction”.

Since the permit data is maintained and updated in the computerized LTC system automatically, there is no need to send PSP notice that a permit was updated or that a duplicate permit was issued.
