MONTHLY POLICE BLOTTER

*The below captions are a summary of significant police responses during the listed month. The blotter does not include all calls for service attended to by the Delaware County Park Police Department.

February 2026

- **02/01/2026 1416 Medical Emergency**
Officers assigned to the Fair Acres complex were dispatched for a Medical Emergency. Officers promptly responded along with Emergency Medical Services (EMS). Officers stayed on the location to assist as needed until EMS was ready to transport the Pt. to the local hospital.
- **02/02/2026 0725 Motor Vehicle Accident**
Officers assigned to Parks Patrol were dispatched to the Delaware County Prison front parking lot for 2 cars involved in a minor accident. A report was taken, and both parties denied any injuries. Registration was expired for one of the parties and a citation was issued. Officers then cleared the call with no issues noted.
- **02/02/2026 1113 Narcotics possession**
Officers assigned to the Courthouse Complex noticed an individual get out of line at a security screening area and throw something in the trash bin nearby. Officers checked the trash bin and found a small container with some unidentified pills. Officers detained the individual to investigate the matter and performed a search. Officers were able to identify the pills were not controlled substances and released the individual to go to their court hearing after obtaining their information. The confiscated pills were submitted to evidence for destruction following the incident.

- **02/02/2026 2215 Medical Emergency**
 Officers assigned to the Fair Acres Complex received a report of a medical emergency. Officer promptly responded along with Emergency medical services (EMS). Officers assisted as needed until Pt. was transported to the local hospital for further evaluation.
- **02/03/2026 1005 Warrants-Outside Agency**
 Officers assigned to Chester District Court were notified by the judge on duty of an individual with an active criminal warrant. Officers took the subject into custody without incident after the warrant was confirmed.
- **02/03/2026 1401 Medical Emergency**
 Officers assigned to the Fair Acres Complex received a report of a medical emergency. Officer promptly responded along with Emergency medical services (EMS). Officers assisted as needed until Pt. was transported to the local hospital for further evaluation.
- **02/05/2026 1414 Warrants**
 Officers assigned to Chester District Court were made aware of an individual on site with an active warrant out of the common pleas court. The subject was taken into custody without incident and then later transferred to Delaware county Prison.
- **02/07/2026 1010 Assist other Agencies**
 Officers assigned to Parks Patrol assisted Marple Township Police Department Officers with a motor vehicle accident that occurred while Marple Township Police Department Officers were at another location assisting with a building fire. Parks Patrol Officers assisted by responding to the accident to check for injuries and to assess the scene for what additional resources might be needed. Following this, Parks Patrol Officers took the report and information to be passed on to Marple Township Police Department Officers.
- **02/08/2026 1510 Medical Emergency**
 Officers assigned to the Fair Acres Complex received a report of a medical emergency. Officer promptly responded along with Emergency medical services (EMS). Officers assisted as needed until Pt. was transported to the local hospital for further evaluation.
- **02/08/2026 1030 Motorist Aid**
 Officers assigned to Parks Patrol discovered a motorist stuck in the snow during winter conditions. Officers were able to assist the motorist by getting their vehicle unstuck so they could resume their travels.

- **02/09/2026 0929 Public Drunkenness**
 Officers assigned to the Courthouse Complex were dispatched to a report of a disorderly subject. Officers made contact with the individual in question and observed that the subject displaying multiple indicators of being under the influence of alcohol. The subject was submitted to a Breathalyzer test and was taken into custody/detained after failing the test. Officers were able to make contact with the individuals family members and after issuing the individual citations for their violations they were released into family members custody.
- **02/10/2026 0948 Warrants/Probation**
 Officers assigned to Chester Adult and Juvenile Probation took the subject into custody for a probation violation. The subject was then later transferred to Delaware County Prison without incident.
- **02/10/2026 1400 Warrants/Probation**
 Officers assigned to Sharon Hill Adult and Juvenile Probation office took a subject into custody for a probation violation. The subject was then later transferred to Delaware County Prison without incident.
- **02/10/2026 1824 Medical Emergency**
 Officers assigned to the Fair Acres Complex received a report of a medical emergency. Officer promptly responded along with Emergency medical services (EMS). Officers assisted as needed until Pt. was transported to the local hospital for further evaluation.
- **02/11/2026 1444 Warrants/Probation**
 Officers assigned to Sharon Hill Adult and Juvenile Probation took A subject into custody for a probation violation. The subject was then later transferred to Delaware County Prison without incident.
- **02/17/2026 0915 Warrants/Probation**
 Officers assigned to Upper Darby Adult and Juvenile Probation took A subject into custody for a probation violation. The subject was then later transferred to Delaware County Prison without incident.
- **02/18/2026 0741 Medical Emergency**
 Officers assigned to the Fair Acres Complex received a report of a medical emergency. Officer promptly responded along with Emergency medical services (EMS). Officers assisted as needed until Pt. was transported to the local hospital for further evaluation.
- **02/18/2026 0927 Warrants**
 Officers assigned to the Courthouse Complex were advised of an individual with an active out-of-county bench warrant. Officers took the subject into custody after confirming the warrant without incident. Detectives contacted the municipality where the warrant was out of to arrange for transport.

- **02/19/2026 1338 Warrants/Probation**
Officers assigned to Chester Probation took an individual into custody for a violation of probation warrant. The arrest took place without incident and the subject was later transferred to Delaware County Prison.
- **02/20/2026 0702 Medical Emergency**
Officers assigned to the Fair Acres Complex received a report of a medical emergency. Officer promptly responded along with Emergency medical services (EMS). Officers assisted as needed until Pt. was transported to the local hospital for further evaluation.
- **02/21/2026 1015 Burglary Alarm**
Officers assigned to Parks Patrol were dispatched to a Burglary Alarm at the Delco Woods property. Officers arrived at the location and conducted a search of the entire property. Nothing was found at the time.
- **02/24/2026 0912 Panic Alarms**
Officers assigned to the Courthouse Complex were dispatched to a report of a panic alarm. Officers promptly responded to find an individual who was visibly upset and crying. Officers were able to assist and calm the individual down so they could conduct their business without further issue.
- **02/24/2026 1726 Drug Possession**
Officers assigned to the courthouse complex discovered a black bag in a courtroom after an employee reported a strong odor of marijuana coming from the immediate area around the bag. Officers searched the bag and identified the owner as well as finding a small amount of marijuana within it. Officers gathered the individual's information and confiscated the marijuana. All confiscated items were submitted as evidence to be destroyed.
- **02/24/2026 1848 Assault**
Officers assigned to Parks Patrol as well as an ambulance were dispatched to a report of a dog bite. Upon arrival, officers assisted the Medics and found further information that an assault had taken place as well as the dog bite. The individual(s) alleged to have assaulted the complainant were gone at the time of the officers arrival leading the officers to gather all information from the complainant for further investigation by the Investigations Division.
- **02/26/2025 1024 Medical Emergency**
Officers assigned to the Fair Acres Complex received a report of a medical emergency. Officer promptly responded along with Emergency medical services (EMS). Officers assisted as needed until Pt. was transported to the local hospital for further evaluation.

- **02/26/2026 1105 Warrants/Probation**

Officers assigned to Upper Darby Probation Office took an individual into custody for a violation of probation warrant. Officers had no issues during the arrest and the individual was later transferred to Delaware county Prison.
