## DELAWARE COUNTY PARK POLICE DEPARTMENT

### MONTHLY POLICE BLOTTER

\*The below captions are a summary of significant police responses during the listed month. The blotter does not include all calls for service attended to by the Delaware County Park Police Department.

April 2026

- **04/01/2026 1210 Medical Emergency**  
Officers assigned to the Fair Acres Division were dispatched for a medical emergency. Officers arrived and assisted and Emergency Medical Services (EMS) prior to the Patient being transported to the local hospital.
- **04/01/2026 1613 Warrants/Probation Violations**  
Officers assigned to the Chester Probation Office received a report of an individual who had violated their probation. Officers took the individual into custody without incident. The subject was then later transported to Delaware County prison (DCP).
- **04/01/2026 1903 County Park Ordinance Enforcement**  
Officers assigned to Parks Patrol discovered another large group of juveniles in Upland Park after hours. Officers proceeded to clear the large group out of the park and again advised that the park was now closed for the evening.
- **04/02/2026 1354 Panic Alarms**  
Officers assigned to the Courthouse Complex were dispatched to a panic alarm on one of the offices within the complex. Officers responded to the office the alarm came from and found an individual causing a disturbance. Officers spoke with all parties involved and found that the subject was asked to step aside after being helped so another individual could be assisted by the employee. The individual had apparently refused to do so, and the employee activated the alarm. After officers spoke with the

individual and gathered as much pertinent information and individual left on their own.

- **04/04/2026 0725 Hazardous conditions**  
Officers assigned to the Courthouse Complex discovered a small electrical fire coming from a powerline at the street level. The fire Dept was dispatched, and Media Police were advised as well.
- **04/04/2026 2043 Medical Emergency**  
Officers assigned to the Fair Acres Division received a call for a Medical Emergency. Officers along with Emergency Medical Services (EMS) responded. Officers assisted as needed until the Patient was transported to the local Hospital.
- **04/05/2026 1958 Suspicious person**  
Officers assigned to Parks Patrol received reports of multiple juveniles who appeared to be loitering just outside the mansion building at Little Flower Park possibly attempting to find a way inside. Officers responded promptly and after searching the area nothing was found. It should be noted that the mansion building is blocked off and is not safe to enter.
- **04/06/2026 1020 Warrants/Probation**  
Officers assigned to the Upper Darby Probation Office were asked by probation officers to perform a search of an individual who was suspected of faking their urinalysis test. Upon searching for the individual, a small bottle filled with a warm yellow liquid was found. The subject was taken into custody and then later transferred to Delaware County Prison (DCP).
- **04/06/2026 1205 Drug Paraphernalia**  
Officers assigned to the Courthouse Complex discovered a small plastic bag filled with a green leafy substance labeled “The Candy Man” while screening an individual through a security checkpoint. Information was gathered on the individual and the paraphernalia was confiscated and submitted as evidence for destruction.
- **04/07/2026 0955 Warrants/Probation**  
Officers assigned to the Upper Darby Probation Office discovered a small foil pouch filled with a green leafy substance consistent with marijuana. Officers advised the subjects probation officer and took the individual into custody for violating probation. The individual was later transported to Delaware County Prison (DCP) and the substance was submitted as evidence for destruction.

Officers assigned to the Sharon Hill Adult and Juvenile Probation Office were advised of an individual who had a violation of probation warrant. The individual was taken into custody and later transported to Delaware County Prison (DCP).
