## DELAWARE COUNTY PARK POLICE DEPARTMENT

### MONTHLY POLICE BLOTTER

\*The below captions are a summary of significant police responses during the listed month. The blotter does not include all calls for service attended to by the Delaware County Park Police Department.

### June 2026

- **06/01/2026 0109 Medical Emergency**  
Officers assigned to the Fair Acres Division were notified of a Medical Emergency in one of the buildings. Officers responded to the call and assisted EMS (Emergency Medical Services) until the patient was transported to a local hospital.
