MONTHLY POLICE BLOTTER

*The below captions are a summary of significant police responses during the listed month. The blotter does not include all calls for service attended to by the Delaware County Park Police Department.

August 2026

- **08/01/2026 0437 Medical Emergency**
Officers assigned to the Fair Acres Division were dispatched to a report of a Medical Emergency in one of the buildings. Officers responded to the call and assisted EMS (Emergency Medical Services) until the patient was transported to a local hospital.
- **08/02/2026 0146 Medical Emergency**
Officers assigned to the Fair Acres Division were dispatched to a report of a Medical Emergency in one of the buildings. Officers responded to the call and assisted EMS (Emergency Medical Services) until the patient was transported to a local hospital.
- **08/03/2026 1045 Warrants**
Officers assigned to the Upper Darby Probation Office were notified of an individual with active probation violation warrants. Officers took the subject into custody without incident. The subject was later transported to Delaware County Prison.
- **08/03/2026 1345 Medical Emergency**
Officers assigned to the Courthouse Complex observed an individual who appeared injured at one of the security checkpoints. Officers provided assistance until EMS arrived. The individual refused any further care, and all parties cleared the call.

- **08/03/2026 2013 Missing Adult Males**
 Officers assigned to Parks Patrol were dispatched to the area of Smedley Park for a missing/disoriented subject. Officers assisted Springfield PD with searching the area. The search was concluded with nothing being found by either dept.
- **08/04/2026 1050 Panic Alarms**
 Officers assigned to the Courthouse Complex received a Panic Alarm for one of the offices inside the complex. Officers promptly responded and found an individual causing a disturbance. The subject was told to leave for the day to which they complied without incident.
- **08/04/2026 1105 Narcotics**
 Officers assigned to the Courthouse Complex were dispatched to reports of an individual reportedly smoking marijuana outside of the Courthouse. Officers located and took the individual into custody. The individual was charged and processed before being transferred to another facility.
- **08/05/2026 1100 Warrants**
 Officers assigned to the Courthouse Complex received a report of an individual on location with an active warrant. Officers located and took the individual into custody without incident. The individual was later transferred to Sheriff's deputies for transport.
- **08/05/2026 1315 Warrants**
 Officers assigned to the Upper Darby Probation Office received a report of an individual on location with an active probation warrant. Officers took the subject into custody without incident. The subject was later transferred to the constable for transport to Delaware County Prison.
- **08/06/2026 1640 Medical Emergency**
 Officers assigned to the Courthouse Complex were dispatched to a Medical Emergency in the Government Center. Officers assisted the individual until EMS arrived. After being evaluated by the medical team the individual refused all care and transport. All units then cleared.
- **08/06/2026 2325 Medical Emergency**
 Officers assigned to the Fair Acres Division were dispatched to a report of a Medical Emergency in one of the buildings. Officers responded to the call and assisted EMS (Emergency Medical Services) until the patient was transported to a local hospital.

- **08/09/2026 Report of Shots fired**
Officers assigned to Parks Patrol were dispatched to Rose Tree Park for shots fired in the area. Officers promptly responded and upon arrival conducted a security sweep of the area. The search yielded negative results and all units cleared.
- **08/10/2026 0133 Fire Alarms**
Officers assigned to the Fair Acres Division were dispatched to a Fire Alarm activation in one of the buildings. Officers responded along with Fair Acres Maintenance crews finding an air conditioner unit had a bad motor.
- **08/11/2026 0925 Warrants**
Officers assigned to the Chester Probation Office were notified of an individual with an active probation violation warrant. Officers took the subject into custody without incident. The subject was later transported to Delaware County Prison.
- **08/11/2026 1200 Disorderly Conduct**
Officers assigned to the Courthouse Complex were monitoring a large group of individuals from both sides of a court trial when the group became disorderly. Officers attempted to disperse the crowd back while issuing lawful commands and after several attempts at this failed, one individual was arrested for disorderly conduct. Officers were able to disperse the crowd and return the area to normal activities shortly thereafter.
- **08/12/2026 1130 Medical Emergency**
Officers assigned to the Courthouse Complex were dispatched to a medical emergency. Officers promptly responded and assisted as needed. Medics arrived on location and evaluated the Patient. After some time, the Pt. refused further care, and all units cleared the call.
- **08/12/2026 1230 Warrants**
Officers assigned to the Chester Probation Office were notified of an individual with an active probation violation warrant. Officers took the subject into custody without incident. The subject was later transported to Delaware County Prison.
- **08/13/2026 0915 Medical Emergency**
Officers assigned to the Fair Acres Division were dispatched to a report of a Medical Emergency in one of the buildings. Officers responded to the call and assisted EMS (Emergency Medical Services) until the patient was transported to a local hospital.
- **08/15/2026 2046 Noise Complaints**
Officers assigned to Parks Patrol received reports for Loud noise and music at one of the parks. Officers arrived to find approximately 250 people with a park permit that expired at 2000. Officers began dispersing the crowd and stayed on location until all parties left.

- **08/16/2026 2111 Assist other Agencies**
Officers assigned to Parks Patrol assisted local Fire Dept search team with gaining access to county owned area. Officers assisted as needed and then cleared later without incident.
- **08/17/2026 0100 Burglary**
Officers assigned to Parks Patrol were dispatched to a burglary alarm at the Delco Woods Property. Upon arrival, officers searched the building which the alarm was activated in and located an individual within the building. After a foot pursuit and a search of the wooded area of the property, two individuals were found and apprehended. Both individuals were charged, processed and transported to DCP.

Officers assigned to the Upper Darby Probation Office were asked by CID to assist with the legal seizure of a juvenile probation client's phone. Officers assisted as needed without incident and then cleared.
