**Attention Delaware County High School students**; are you interested in a real life experience in how our election process works? Delaware County Bureau of Elections may have an opportunity for you! The Bureau of Elections is looking for qualified individuals to help assist in working the polls on Election Day.

## Requirements-

According to the Pennsylvania Election Code 25 P.S. 2672 (b) The County board may appoint students, notwithstanding their eligibility to vote, to serve as a clerk or machine inspector pursuant to the following:

- (1) The county board may appoint no more than two students per precinct
- (2) The Judge of Elections shall have direct supervision of the student
- (3) The county board may compensate the student
- (4) The county board shall comply with all applicable Federal and State laws
- (5) The student must be at the time of the election for which the student shall serve:
  - (i) be at least seventeen (17) years of age;
  - (ii) be a United States citizen and a resident of the county in which he was appointed to serve
  - (iii) be enrolled in a secondary educational institution with an exemplary academic record as determined by the educational institution;
  - (iv) be approved by the principal or director of the secondary educational institution; and
  - (v) have obtained the consent of their parent or guardian.

The student may not serve as a Judge of Election, Majority or Minority Inspector.

## **Expectations-**

- Students are required to have the permission form signed and returned back to Voter Services prior to the election.
- Students that are 17 must follow state labor laws and can only work a half day. While students who are 18 may work a full day.
- Students are expected to work their entire shift.
- Students are required to attend a training class prior to Election Day. (Training class schedule is posted on the Bureau's website (www.co.delaware.pa.us/elections/election.html)
- If room is available students can expect to be placed in a precinct that is within their school district, with the priority going to their household precinct location.
- Students working the polls can expect to be paid by check a 3-4 weeks after the election.

## How to apply?

Simply fill out the form on the opposite side and return it to Delaware County Bureau of Elections prior to the next election. Both halves of the consent form need to be completed before turning in to the Bureau of Elections. A welcome packet will be sent with the training schedule and precinct enclosed.
